Conditions of Entry

Please sign overleaf that you accept these conditions;

1. I acknowledge that a triathlon involves a certain element of risk, serious injury or even death from various causes including overexertion, equipment failure, dehydration, & accidents with other participants, spectators or path users, course or weather conditions and other causes.
2. I understand that I/mychild have/has undertaken sufficient training and have/has acquired a level of fitness necessary to complete this event.
3. By being involved in this event, I accept all risks necessarily following from my/my childs participation that could result in loss of life or permanent injury. Accordingly, I release all persons or corporations associated directly or indirectly with the conduct of the event from all claims demands and proceedings arising out of my participation and I hereby indemnify them against all liability (including liability for their negligence and the negligence of others) for all injury, loss or damage arising out of or connected with my participation in this event. [This release shall extend to and include Queensland Police Citizens Youth Welfare Association, Bayside PCYC, Manly Chamber of Commerce, Triathlon Queensland and Surf Life Saving Australia](#) and their respective directors, partners, managers, officers, agents, contractors, employees and volunteers including medical and paramedical personnel appointed for the event, the owners, licensees and occupiers of land upon which the event or any part of it is conducted, any statutory body or local authority having control over land upon which the event or any part of it is conducted or which is involved directly or indirectly with the event in any manner whatsoever and promoters, sponsors and event organisers. This release and indemnity continues forever and binds my/my childs heirs, executors, personal representatives and assigns.
4. I consent to myself/my child receiving any medical treatment including ambulance transportation that the event organisers think desirable during or after the event.
5. I consent to event organisers using my/my childs name, image and likeness before, during or after the event for promotional broadcasting or reporting purposes in any media.
6. I understand that compulsory insurance cover affected for participants in this event may not cover me/my child for any or all injury, loss or damage sustained by me/my child.
7. Safety precautions undertaken by organisers (such as course supervision, race safety briefings) are a service to me/my child and other participants but are not a guarantee of safety.
8. I am fully responsible for the security of my/my childs personal possessions at the event.
9. My/my childs registration is not transferable to other people. If I/my child am/is unable to compete, or if the event is cancelled by way of circumstances beyond the control of the event directors, my/my childs registration fee is non-refundable.
